- No video recording, audio recording or photography is allowed unless given permission from an appropriate administrative associate.
- Visitor pass should be returned to the issuing party when signing out.

Any unauthorized visitor failing to adhere to this policy will be asked to leave the premises.

Signs will be placed at both centers to insure this policy will be adhered to.

The Board of Directors approved the Policy and Procedures as noted.

Tim Lewis stated his mother received a letter in the mail requesting permission to use her photograph. The letter was legitimate as the request came from DSI in regards to home delivered meals. The photograph is used to insure the recipient was accurate.
