COMITTEE REPORTS

EXECUTIVE COMMITTEE: Chairman Emily Watts

The Executive Committee met multiple times with several meetings held in Executive Session.

FINANCE COMMITTEE: Chairman Haren Main

The Finance Committee met several times. As a result of the meetings, the following motions are to be presented today.

- Move to make the change requested by the County, to our official Budget for the 2023-2024 fiscal year, to increase projected income from Dorchester County to \$1,487,256.
 Motion carried.
- Move that DSI's "Emergency Fund" be increased from the current \$41,000 to \$50,000.
 This fund would be accessed only in the event of an unanticipated failure of equipment, systems or facilities or in the event of a natural disaster and would only be used if the amount needed exceeded \$5,000. Any usage of the fund would only be replaced upon a vote of the Board authorizing it. Motion carried.
- Move that DSI invest it's "Emergency Fund", along with it's "Fundraising Net Proceeds Fund" and excess operating funds, in SIPC insured Money Market Mutual Funds, to be held, along with it's other investments, at Edward Jones. Available operating funds would be set with a floor of \$400,000 and a ceiling of \$600,000. Motion carried.
- Move that we authorize the purchase of an ADA compliant bus that is coming off lease this month. The cost will be \$22,000. Motion carried.

GOVERNANCE COMMITTEE: Chairman James Villeponteaux

The Governance Committee met multiple times to discuss the issue of the flooring in the St. George facility. A motion is being presented today from the committee:

 To more forward and proceed with funding on the core drilling of the foundation to determine where the water is coming from. Terra Com has quoted a cost of \$1210, The Mayor has agreed to split the cost equally between St. George and DSI. Each entity will pay \$605. The motion passed. **DEVELOPMENT AND FUNDRAISING COMMITTEE-** Co-Chairman Carol Davis and Pamela Kelly

Chairman Watts called on Co-Chairman Pamela Kelly to submit the report as the Chairman Carol Davis was not in attendance. She proceeded to advise the Board on the Spring Gala held on April 22, 2023. The event was held at DSI and was enjoyed by all.

NOMINATING COMMITTEE: Chairman Tim Hudson

Chairman Hudson discussed how DSI board members should participate in DSI. He pointed out that in addition to attending meetings, etc., he suggested that members of the Board should also donate at least \$100 to the center annually. As no motion with as second was made, there was no vote.

EXECUTIVE DIRECTOR'S REPORT: Leigh Thompson

Executive Director Leigh Thomson took this opportunity to update activities at the Summerville center as well as the St. George center. She also requested that the Board go into Executive Session.

Chairman Watts invited Deputy Director LaQuinta West to speak to the Board about her duties at DSI. Center Manager Beth Greene was also invited to speak to the Board about her duties at DSI.

NEW BUSINESS: It is now time to place your bids on the MacBook. Director Thompson announced Tim Hudson as the winner with a bid of \$1,125.12.
